- 1 recent identical passport quality photographs on a Light background (50mm x 50mm or passport size) scan which must be in JPEG format, square, between 10kB and 1Mb in size, and a minimum 350 x 350 pixels or send by post.
- E-Business, Copy of your Business Card with your name, company name, company or business affiliation and contact information is required
- E-medical, Letter from appropriate Indian Hospital on their letterhead where treatment is taking place.
- E- Visa Processing time & Fees, 24 Hours £100.00, 3 Days £90.00, 7 Days £83.00
